#### Respected Sir,

With due respect, we write to introduce and seek recognition of Bharatiya BSNL Officers Association (BBOA) a selfless, transparent, and ideology-driven officers' movement committed to the motto: Nation First, Department First, Employees First, so that resources can be generated for Revenue to build the Nation and no one stands on this ideology.

- a) Revenue: One PSU One Association how to co-relate the revenue of BSNL.
- b) Shri Ravi Shil Verma AGM: Not in order as per existing Order issued on 19.09.2023 regarding 200 KM Arial distance. Para-6 (D) & 7 etc. (Copy enclosed) that "For the purpose of Counting of Circle Tenure under BSNL Transfer Policy the Executives serving in BSNL CO, CNTx-N, QA&I, BBNW, ALTTC, INMARSET, UP(W) & HR Circles and posted in the State of Delhi & Municipal limits of Gurgaon, Faridabad, Noida, Greater Noida & Ghaziabad shall be treated as one composite Unit and will be counted as tenure of Delhi/BSNL CO"
- c) Clarification regarding BSNL Transfer Order List dated 02.05.2025 Change Page-5 at Serial No. 42: Annexure-I (Copy enclosed).
- ➤ A BSNL transfer order list of 740 officers was uploaded on the intranet on 02.05.2025 subsequently removed. As per Page No. 5 of the available copy, only Serial No. 42 shows a change - Shri Ravi Shil Verma, AGM (Perner No. 204093), was transferred on promotion from BSNL Corporate Office, Janpath, New Delhi to CNTX-N, Janpath, New Delhi, instead of UP(E). A copy of the relevant pages (2 pages) is enclosed for reference.

Kindly clarify the reason for the removal of the list, the current status of the said transfer, and whether a revised or updated list will be issued for official transparency.

- f) Immunity: "An officer who has already been granted all types of immunity should not be given any undue advantage, as it is against the established rules. If such a benefit has still been granted, it must be clarified under what reasons and under what kind of pressure it was given. The said decision should be withdrawn with immediate effect."
- g) Order Impact on Employees: Overall the employees seem to have a negative image of BSNL, which should not be appropriate as per the policy.

# > As per the Constitution of India:

"India is a democratic nation where a multi-party system is not only recognized but is fundamental to its functioning. Just as one country cannot be governed by a single political party, similarly, one Public Sector Undertaking (PSU) like BSNL cannot represent all its officers and employees through a single association. Such a concept violates the core principles of the Constitution—liberty, equality, and freedom of expression. Every employee has the constitutional right to associate freely and choose an organization that reflects their beliefs and interests. Therefore, the idea of "One PSU, One Association" is inherently undemocratic and must be opposed in the interest of fairness, representation, and justice."

BBOA was born out of growing disillusionment with non-transparent functioning, groupism, and declining trust in certain legacy associations. We aim to bring a fresh, honest perspective to officer representation across BSNL and MTNL, especially in the context of the ongoing merger and structural reforms.

#### 1. Key Principles of BBOA:

- National Commitment: Every action purely devoted towards National Ideology.
- Departmental Integrity: Full support to BSNL-MTNL revival through ethical, accountable conduct.
- Officers' Welfare: Focused on protecting the dignity and rights of absorbed, promoted and directly recruited Officer's.
- Unified Representation: Advocating for "One PSU One Transparent Association" free from
  political influence and performing without any interruption in the interest of BSNL as well as
  employees.

# 2. About the Undersigned:

I, **Rajender Singh Tushir**, retired Accounts Officer (BSNL) and Ex-Chief Coordinator, MTNL Officers Association (Mumbai & Delhi, 1999–2005), have dedicated my post-retirement years to unifying officers under a principled and transparent platform. Today, BBOA is backed by likeminded officers across India who believes in accountable, apolitical leadership.

## 3. Our Humble Requests:

- Official recognition of BBOA in all consultative and policy-making platforms.
- Inclusion in HR and structural dialogue relating to merger implementation and officer rights.
- Instructions to all BSNL/MTNL units to acknowledge BBOA as a stakeholder in officer-related matters.

# 4. Separate Submission: Concern over Misuse of "One PSU - One Association" Slogan:

We also wish to highlight growing frustration among BSNL/MTNL officers over the manipulative use of the slogan "One PSU - One Association" by three associations - SNEA, AIGETOA, and AIBSNLEA - without holding a legitimate majority or ensuring true representation i.e. 51%.

#### 5. Key Concerns:

- a) **Deceptive Unity Claims:** These groups have failed to deliver on employee-centric issues while indulging in backdoor deals and internal pacts.
- b) Pay Parity Ignored:
  - BSNL JAO/JTO basic: ₹9,850
  - MTNL JAO/JTO basic: ₹10,750
  - "One PSU One Rule" Why should not applied in pay structures to all? Factors may kindly be reviewed.

### c) False Representation Metrics:

- SNEA: Vote leadership, but lacks mass support.
- AIGETOA: Large membership but underperforms electorally.
- AIBSNLEA: Minimal relevance today.

### **Our Suggestions:**

- De-recognize these legacy associations for lack of genuine representation.
- Implement a transparent "One PSU One Association" policy.
- Recognize BBOA as a credible, honest, and future-ready officers' platform.
- Ensure equal time, platform, and respect for all legitimate groups.
- Grant long-awaited benefits like 15% Pay Revision (3rd PRC), LTC restoration and One cadre One Scale (JTO/JAO).
- Restore additional one Increment on promotion. Why not take up by SNEA, AIGETOA & AIBSNLEA and other's.

#### Conclusion:

- i) BSNL and MTNL Officers deserve transparent leadership not political manipulation. BBOA stands ready to work shoulder-to-shoulder with management to restore trust, enhance morale, and build a unified telecom force aligned with national goals.
- ii) If not stopped immediately, this policy will trigger protests and unrest, leading to service disruptions and customer dissatisfaction just like in February, 2019 and other past instances. Prolonged salary delays had already worsened employees' conditions. Immediate withdrawal of this policy is essential to avoid further damage.

Subject:- Annual Transfer and Posting of Officers in various cadres of Telecom/Finance/ Civil/ Electrical stream due to Promotion, Own request, Long stay etc., – Regarding.

The Officers listed in the enclosed Annexures, belonging to various cadres of Telecom/Finance/Civil/Electrical/Architecture/Telecom Factory stream are hereby transferred and posted to the circle indicated against their names due to reasons such as Promotion, Own request, Long stay etc., with immediate effect and until further orders.

- 2. The conditions prescribed in the Order under Ref-2 in respect of the officers promoted to the grade of DE/AGM(T) regular on provisional basis against 33% competitive quota against LICE for vacancy year 2023 shall be strictly complied with.
- 3. CGMs to relieve the executives who have been ordered for transfer to other circles immediately but not later than 15 days from the date of issue of this Order. In case the executives concerned fails to join the promotional assignments within the prescribed period, he/she should not be allowed to join the post thereafter. In such a situation, the promotion order shall become inoperative and such cases shall be reported to this office. Further, no request for modification of posting order shall be entertained.
- 4. The officers on Proforma Promotion or presently on deputation shall join at the posted circle on completion of the deputation period.
- 5. Further, the Officers listed in the enclosed Annexures, belonging to various cadres of Telecom/Finance/Civil/Electrical stream are hereby transferred and posted to the circle indicated against their names due to reasons such as Promotion, Own request, Long stay etc., with immediate effect and until further orders.

CGMs concerned are further advised that the pendency of request of the
executives for modification of the posting order should not be taken as ground for
holding up the implementation of this order.

7. The leave, if any requested by the executives, who are covered under this Order, should not be allowed. If any executive desires leave, he/she can apply for leave to new place of posting under whom he/she has been posted only after joining the new assignment. The new controlling executives will sanction leave, if it is considered justified as per norms.

8. Officers working at Tenure stations shall be relieved only on successful completion

of Tenure stipulated.

9. All the executives are posted to the circles as indicated in column "Posted Circle" of the annexure. However, the management reserves the right to modify their postings as per administrative requirements

10. Circles shall implement all intra-circle transfer as per the transfer policy issued by

Corporate Office within next 15 days.

11. Circles shall post AGMs at SDCA headquarters of posting them in OA/BA/Circle offices. Similarly, officers at other levels also shall be posted in the field units instead - of concentrating in the OA/BA/Circle offices to ensure operational requirements.

12. Revenue generating posts in EB, CM and CFA verticals shall be filled up on priority.

- 13. Officers should not be posted at locations where they have served extensively in the past. Rotation of officers across various posts and across different verticals must be ensured to maintain transparency and efficiency. Allowing officers to continue in the same place/same post/same vertical for a long period should generally be avoided.
- 14. Circles shall ensure that the working strength at Circle and OA level is evenly distributed. Difference in ratio of working strength and sanctioned strength between Circle Office and BA/OA level should not be more than 10%. Similarly, the difference in ratio of working strength and sanctioned strength between BA/OA Hars Office and BA/OA field units respectively should not be more than 10%.
- 15. After the issue of Annual Transfer Orders, issue of intra-circle transfer orders involving change of station may be avoided except in the case of critical medical cases or Administrative/ Organizational requirement. Corporate office should be kept informed about such orders along with justification.

16. Transfer and posting of only DGM and below level executives will be done by the Circles. Posting of Officers above DGM Level including interchange/shifting at the

level of GM & above shall be done by Corporate Office only.

17. Circles shall not give look after charge at the level of GM & above without the

approval of Director HR.

18. Circles shall not issue orders for looking after arrangement beyond the strength authorized by Corporate Office and excess already ordered shall be cancelled

immediately.

19. BSNL CO-PETS/11(11)/4/2020-PERS1 dated 27.12.2023 directing circles to avoid intra-circle transfer of executives having station stay of more than 20 years stands withdrawn with immediate effect. Officers under transfer liability are advised to exercise OTP request preferably to shortage circles, well in advance and move out in their own interest so as avoid double transfer (intra and inter circle) within a short period.

20. Executives or their immediate family/dependents should not bring any external influence in the matter of service matters including their transfer and postings. All

such cases will be dealt strictly as per provisions of BSNL CDA Rules.

21. Chronic Medical cases and exemption on medical grounds with proper entry in ERP will be given due consideration as per the guidelines of BSNL subject to verification of records either administratively or through second medical opinion or both. Any false representation will attract the provisions of BSNL CDA rules. On receipt of representation if any from the officers under transfer, Circle Head shall get the cases verified thoroughly in accordance with the guidelines on this subject. Genuine and deserving cases may be referred to Director HR under the signature of Circle Head with specific recommendation.

22. Posting of executive(s) to the sensitive / non-sensitive post may be decided by the concerned circle as per prescribed norms circulated by DOT & Vigilance branch

of BSNL Corporate Office from time to time.
